



2010 Artist Entry Information

This art exhibit and sale will take place in Yountville, CA on Saturday, August 21, 2010.

This is not a Plein Air paint out nor is it a themed exhibit. It is an opportunity for artists to show and sell a variety of representational artwork created within the last year.

Jury Selection and Eligibility

- A jury consisting of artists Kevin Macpherson and Kathryn Stats and Jean Stern, Director of the Irvine Museum will select the 2010 participating artists.
- Selections are based on submitted digital images of work executed since January 1, 2009.
- Eligible artwork must be original representative oil paintings, water color, acrylic or pastel.
- No photography, prints, sculptures, glass, fiber, functional art, ceramics, charcoal/pencil drawings, reproductions, giclée, jewelry, woodwork or three dimensional art will not be considered.

Event Requirements

- You will be provided with panels to display your artwork. The event is indoors so umbrellas or tents will not be necessary.
- Set up begins at 8:00 and must be completed when the event opens at 10:00. The event will last until 4:00. Please be prepared to stay until this time.
- 40% of proceeds from the exhibition and sale will go to the Connolly Ranch Education Center (a nonprofit organization). Artists will retain 60%.

Entry Requirements (All requirements must be complete)

- All entries must be received by March 1, 2010.
- Submit 3 high resolution digital images of current work (since January 1, 2009) on a CD-Rom. (The work you submit does not have to be work you will exhibit at the event.)
- Complete the Entry Form.
- Mail the Entry Form with a \$40 check made payable to Connolly Ranch.
- Include these items with your submission:
 - A self-addressed stamped #10 envelope
 - 3 digital images in jpeg format on a CD-Rom. Resolution must be at least 300 dpi with smallest length/width dimension to be no less than 4 inches. (No slides will be accepted.)
